NEW BUSINESS

A motion was made by Goldammer and seconded by Reimnitz to approve the minutes from the November 18, 2021, meeting. All members voted in favor of this action; motion carried.

Six building permits were reviewed by the Board.

Two letters from the Department of Agriculture and Natural Resources for County Line Feeders and Bernard Van Vuuran Inc. were reviewed by the Board with no action needed.

PLAT APPROVAL:

A motion was made by Goldammer, seconded by Star, to approve the following plat: A plat of Lot 1 of Spaans Addition in the NW $\frac{1}{4}$ of Section 27, T100N, R64W, of the 5th P.M., Douglas County, South Dakota.

All members voted in favor of this action; motion carried.

PUBLIC HEARING-CONDITIONAL USE

A motion was made by Reimnitz and seconded by Star to recess as the Planning and Zoning Board and convene as the Board of Adjustment to conduct a public hearing for a conditional use permit. All members voted in favor of this action; motion carried.

At 6:35 p.m., Chairman Fuoss declared the public hearing open. Said public hearing was to review a request for a conditional use permit under section 517 of the Douglas County Zoning Ordinance: Request for a one-time application of biosolids from Delmont Municipal Lagoon to adjacent farmland, located in Part N ½ North of Railway and Part N ½ South of Railway and Railroad (Except Tract 1) of Section 35, T 98 N, R 62 W, in Belmont Township, Douglas County, South Dakota. Town of Delmont, PO Box 202, Delmont, SD 57330 Applicant and HB of South Dakota LLC, 41181 179th Street, Raymond, SD 57258 Owner of Land. Jacob Sonne, P.E for SPN & Associates, was present to explain the project. Sonne explained that the project has also been reviewed and will meet all of the requirements set forth by the South Dakota Department of Agriculture and Natural Resources. This includes incorporating the biosolids into the soil within six hours of application. Discussion was held. Chairman Fuoss declared the public hearing closed. A motion was made by Star and seconded by Goldammer to adjourn as a Board of Adjustment and reconvene as the Planning and Zoning Board. All present voted in favor of this action; motion carried. A motion was made by Reimnitz and seconded by Star to approve the Conditional Use Permit submitted by the Town of Delmont according to section 517 (8) of the Douglas County Zoning Ordinance and in accordance with the DANR Guidelines. A roll call vote was taken with the following votes recorded: voting 'aye': Star, Goldammer, Reimnitz and Fuoss. Voting 'nay': none. Absent: Lefers and Olawsky. Motion carried.

OTHER BUSINESS

Jay Spaans, Douglas Electric Cooperative, met with the Board to ask for clarification on the 10-acre minimum for purchasing land to build on. Spaans is looking for ways to encourage people to build in rural Douglas County. Discussion was held with no action required.
